### RECITALS

- A. By Master Declaration of Covenants, Conditions and Restrictions for Redlands Mesa recorded July 17, 2000 in Book 2730 at Page 66 in the Office of the Clerk and Recorder of Mesa County, Colorado, (the "Master Declaration"), Declarant created a Common Interest Community known as Redlands Mesa.
- B. Under Section 6.5 of the Master Declaration, Declarant reserved the right to annex to the Common Interest Community all or any part of the "Annexable Property" described in Section 2.3 of the Master Declaration.
- C. By First Supplemental Declaration to Master Declaration for Redlands Mesa recorded May 16, 2001 in Book 2851 at Page 9 of said records, Declarant annexed a portion of the Annexable Property to the Common Interest Community.
- D. By Second Supplemental Declaration to Master Declaration for Redlands Mesa recorded December 17, 2001 in Book 2982 at Page 820 of said records, Declarant annexed a further portion of the Annexable Property to the Common Interest Community.
- E. By Third Supplemental Declaration to Master Declaration for Redlands Mesa recorded December 18, 2003 in Book 3553 at Page 935 of said records, Declarant annexed a further portion of the Annexable Property to the Common Interest Community.
- F. Declarant desires by this Fourth Supplemental Declaration to annex to the Common Interest Community further portions of the Annexable Property, consisting of eight (8) additional Lots (in two separate Filings) and certain other lands, and to amend the Master Declaration accordingly, and to reallocate the Allocated Interests of all Lot Owners in the Common Interest Community accordingly.

### SUPPLEMENTAL DECLARATION

NOW, THEREFORE, for the purposes set forth in the Master Declaration, Declarant, for itself and its successors and assigns, hereby declares as follows:

1. The real property described on Exhibit A attached hereto and made a part hereof by this reference is hereby annexed to and made a part of the Common Interest Community known as Redlands Mesa. The property annexed by this Fourth Supplemental Declaration is hereinafter referred to as Redlands Mesa Filings 4 and 6, respectively.

- The definition of "Common Interest Community" set forth in Section 2.14 2. of the Master Declaration is hereby amended by the addition thereto of Redlands Mesa Filings 4 and 6, and all of the lands within said Redlands Mesa Filings 4 and 6 are hereby made expressly subject to the Master Declaration and all covenants, conditions, restrictions, limitations, assessments, charges, servitudes, liens, reservations, exceptions, easements, privileges, rights and other provisions set forth therein, except as modified below.
- With respect to Redlands Mesa Filings 4 and 6, respectively, Declarant expressly reserves to itself and its successors and assigns all of the rights set forth in Article 6 of the Master Declaration, as well as any other rights reserved by or to Declarant in the Master Declaration.
- The Allocated Interests of all Lot Owners in the Common Interest Community are hereby reallocated as set forth in Exhibit B attached hereto and made a part hereof by this reference, and Exhibit A ("Allocated Interests") to the Master Declaration is hereby amended, replaced and superseded in its entirety by said attached Exhibit B.
- The recorded easements and licenses appurtenant to or included in Redlands Mesa Filings 4 and 6, respectively, are set forth on Exhibit C attached hereto and made a part hereof by this reference.
